1. Introduction

- 1.1 The purpose of this document is to inform students of all Terms and Conditions in relation to booking any course with Inner Spiritual Journey.

2 Terms and Conditions

- 2.1 In the event of a student withdrawing from a course, all outstanding fees must be paid in full at the time of the students' withdrawal. Inner Spiritual Journey cannot accept any withdrawals unless they are in writing.
- 2.2 Any cancellation received more than 4 weeks prior to the course start date shall entitle Inner Spiritual Journey to a cancellation fee equivalent to 25% of the total cost of the course. Cancellations received 4 weeks or less prior to the course start date, shall entitle Inner Spiritual Journey to a cancellation fee equivalent to the full course fee.
- 2.3 In the event of a student failing to attend or complete a confirmed, course, for any reason, however so determining, no refunds will be made by Inner Spiritual Journey.
- 2.4 Course fees include tuition, accredited certification, training materials, resources, manuals and handouts as deemed appropriate by Inner Spiritual Journey for each course.
- 2.5 Course fees do not include additional items where required, such as student work wear. These items are an additional expense and are met by the student.
- 2.6 In certain circumstances it may be necessary for Inner Spiritual Journey to reschedule or cancel a course. If the rescheduled dates of the course are not convenient to you, Inner Spiritual Journey's liability will be limited to a refund only, of any course fees paid.
- 2.7 Inner Spiritual Journey reserves the right to alter the course venue and timetable where necessary at any time.
- 2.8 Inner Spiritual Journey reserves the right to alter the course contents and structure where necessary at any time.
- 2.9 Inner Spiritual Journey reserves the right to determine the numbers of attendees on a course at any time.
- 2.10 Inner Spiritual Journey reserves the right to decline applications for valid reasons.
