## 1. Introduction

- 1.1 The purpose of this document is to inform Client of all Terms and Conditions in relation to booking any Treatment with Inner Spiritual Journey.

## 2. Terms and Conditions

- **2.1 GDPR Consent**

As of 25 May 2018 new legislation, GDPR (General Data Protection Regulations) came into force.

This concerns everyone, and you as the customer have rights to your Data and what businesses do with it.

To know how we collect, store and use your data, please refer to our Privacy Policy on our website, or you can request a printed copy.

Within the terms specified by GDPR legislation we need you to agree with the statements below and consent for us to collect, use and store your information.

Inner Spiritual Journey (Data Controller) will hold my details electronically on a secure and encrypted cloud based database.

My data will only be accessed and viewed in relation to booking appointments with The Data Controller, in preparation for my Appointments and to record Client notes after my Appointments.

My Data will not be share with any Third Party, unless it is deemed, by The Data Controller that a Safeguarding concern notification needs to be raised.

Inner Spiritual Journey will only contact you in relation to appointments via email, text or telephone.

## 2 Terms and Conditions

- **2.2 Hypnotherapy Consent**

A named Therapist from Inner Spiritual Journey to Hypnotise me in accordance with my wishes.

During the session, I understand that I will be in full control of my body, at no time will my named Therapist have 'control of me' and thereby be able to have me perform.

- **2.3 General Hypnosis**

Hypnosis at Inner Spiritual Journey is only ever utilised for Therapeutic purposes, this can include, but not be inclusive:

Weight Loss  
Confidence Building  
Anxiety  
Smoking Cessation  
Insomnia

All sessions will have a written record undertaken by the named Therapist.

- **2.4 Past Life Regression**

Past Life Regression session's are audio recorded, a copy of this session will be past onto the Client, with the recording of the Hypnosis removed.

- **2.4 Virtual Services**

Any 'Virtual Services' offer by Inner Spiritual Journey, including but exclusively Virtual Coaching, Distance Healing ETC require payment to be made a minimum of 24 hours before scheduled appointment. An invoice will be issued 48 hours prior to the allotted appointment time.

If payment is not made then the appointment will be cancelled and no service offered.

## 2 Terms and Conditions

- **2.5 Failure to attend / Cancellation**

As of September 01, 2022 if any Client fails to attend any Treatment without prior notice, or give a minimum of 48 hours notice they will be invoiced for the full total of the Therapy.

If this invoice is not paid in full within 15 days it will be passed onto a recovery .

ISJ is run by a sole practitioner, Fiona Partridge. Fiona has a young family and although unfortunate it be necessary to postpone your treatment at short notice if there is illness. Please rest assured Fiona will do everything to ensure your Treatment goes ahead, however if suitable arrangements cannot be made, then she will offer an alternative date at the earliest appointment slot.
