How we get the personal information and why we have it

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- Student enrolment, to enable us to hold relevant and specific information to enable safe teaching Practice
- Patient in-take form, to establish that it is safe to proceed with desired Treatment

We also receive personal information indirectly, from the following sources in the following scenarios:

 Verbal confirmation I.e updating any current or sudden onset medication conditions, to enable alterations to comfort settings during treatments

We use the information that you have given us in order to provide the best possible treatments and teaching setting

We may share this information with no other organisation unless we feel there is a Safeguarding risk, then all information relating to the risk will be handed over to the relevant authorities. The individual will be informed that this is going to happen prior to the event.

How we store your personal information

Your information is securely stored.

We keep all Client and Student records on a double encryption cloud based Therapy Practice database / software mechanism for the period they are active. Once a Client and or Student becomes dormant their information is achieved within the system We will then dispose your information 5 years after the information become dormant.

Your data protection rights

Under data protection law, you have rights including:
